Los Angeles International Airport Non-Exclusive License Agreement (NELA) Renewal

Dear Mr. Stewart,

International Bonded Couriers, Inc. (IBC) has at-will agreements with China Airlines, Qantas Airways, United Parcel Service to provide in-bond recovery services from planeside to IBC's Express Consignment Clearance Facility (ECCF). The agreements between IBC and China Airlines, Qantas Airways, United Parcel Service began on March 9, 2004, and shall continue in force unless terminated by either party giving to the other not less than 30 days written prior notice to expire. Other carriers served by IBC include, but are not limited to AC, BR, CX, JL, MU, MX, NW, UA, and AA.

We will be providing in-bond recoveries and Delivery Services of express cargo shipments from each of the carriers' planeside and transfer to IBC's Express Consignment Clearance Facility (ECCF), as per Customs and Border Protection (CBP). IBC is required by CBP regulations to provide in-bond recovery services from planeside to our ECCF. These services will be performed at Tom Bradley International Terminal, ICC and Bravo ramps, Cathay Pacific Cargo Terminal, China Airlines Cargo Terminal, Terminal 2, 4, UPS Facilities in LAX and ONT.

Pedestrian access to the Airport Area Operations (AOA) is required to perform the duties of the contract.

Tools/equipment will be used to fulfill contract obligations therefore, vehicle access to the airfiled is required. Vehicles are street licensed
