

United Airlines East Aircraft Maintenance Hangar Project Fiberoptic Cable Pull

The United Airlines East Aircraft Maintenance Hangar Project will require multiple closures of Runway 25R, Taxiway B and Taxiway C for fiberoptic cables to be pulled through an underground duct bank between several manholes that are within the runway and taxiway safety areas. This fiber pull project will take place over the course of approximately eight weeks starting May 17, 2021 through July 08, 2021 during nighttime hours 0030-0530 PDT. Phase 12 of this project, currently scheduled for June 26th and June 27th 2021 (0030-0530), will impact aircraft repositions between terminal gates and aircraft parking spots at Taxilanes B1, C1, C3, and C5 due to simultaneous closures of Taxiways B and C. If aircraft repositions are required during these hours, airlines will need to contact the ARCC prior to pushing from the gate or overnight parking spot for Airport Operations to escort the aircraft onto the closed Runway 25R to get around the taxiway closures. To reduce the need for aircraft escorts onto the closed runway, Airport Operations requests that airlines plan aircraft repositions before 0030 and after 0530 on these two night if possible. Operational Impacts:

- Runway 25R will be closed nightly 0030-0530.
- Segments of Taxiway B will be closed between Taxiways F and B4 nightly 0030-0530.
- Taxiway C between Taxiways C1 and C3 will be restricted to B737-900 and smaller aircraft (wingspan less than 118 feet) under tow only (no aircraft taxi under power) during a majority of the phases, nightly 0030-0530. This will allow continuous access for aircraft under tow to reposition between the terminal gates and overnight parking spots at Taxilanes B1 and C1 for the majority of the phases.
- Taxiways B and C will be closed simultaneously 0030-0530 June 26th and June 27th for Phase 12, requiring any aircraft repositions to Taxilanes B1, C1, C3, and C5 to be escorted by Airport Operations via closed Runway 25R.
- LAX will need to remain in the west traffic configuration overnight June 15th through June 18th and June 26th through June 27th due to the closure impacts to available taxi routes.

Notices to Airmen (NOTAMs) will be issued 120 hours prior to the scheduled closures. Please plan flight operations accordingly. For current airfield operating conditions please check NOTAMs at <https://notams.aim.faa.gov/notamSearch/disclaimer.html>. Thank you for your support.

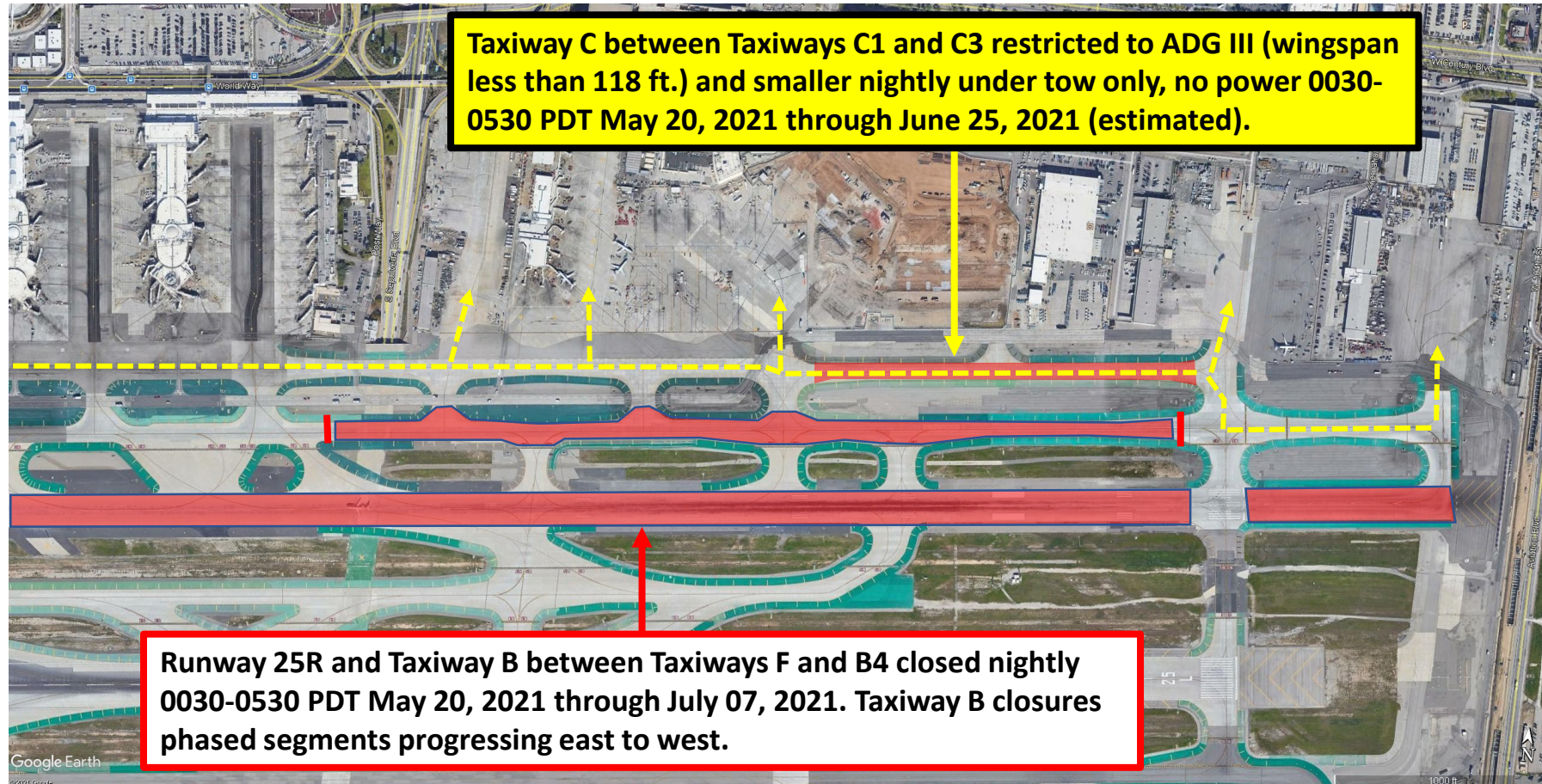
