Fingerprinting and Badging

Prospective volunteers are required to submit and clear the Los Angeles World Airports Security Badging Fingerprint Process. At every fingerprint and/or badge appointment valid proof of identity and eligibility to work in the United States must be presented in its original form for verification **AND** copied format for inclusion with the application itself. The list of acceptable documents are found on the last page of this application. Prospective volunteers must possess the required documents to participate in the LAXceeders Student Volunteer Program.
