Dear Mr. Nicholas

Thank you for your letter dated April 17, 2003 expressing United Homeowners Association, Inc.'s (UHA) interest in membership in the Los Angeles International Airport/Community Noise Roundtable (Roundtable). I must inform you that at this time there are no unfilled At-Large membership positions available.

In May 2002 the Roundtable adopted a set of by-laws, which establishes the membership of the Roundtable. Article III of the by-laws specifies that there are three (3) At-Large memberships as follows:

"The Chair of the Roundtable may designate up to three (3) at-large representatives from recognized community groups or organizations. These at-large members shall be confirmed by a vote of the Roundtable, and will be voting members of the Roundtable. At-large members shall serve a term of two (2) years. They may be re-appointed by the Chair subject to confirmation by a vote of the Roundtable."

During the January 2003 meeting of the Roundtable, three organizations were selected as At-Large members by the Chair and were approved by a vote of the Roundtable for the two-year term. These organizations will serve on the Roundtable until the end of December 2004. A copy of the Roundtable by-law's is enclosed for your reference.


The Secretary of the Roundtable will keep your letter on file. If an At-Large membership position becomes available prior to the end of December 2004, the Chair of UHA's Airport Noise Committee will be notified of the vacancy and a representative of UHA will be invited to the Roundtable meeting to make a presentation on behalf of your organization. The Chairman of the Roundtable will then appoint an organization to fill the vacant position subject to a vote of the Roundtable.

Thank you again for your organization's request to join the Roundtable. All meetings of the Roundtable and its subcommittees are open to the public, and UHA's representatives are welcome to attend and comment on the issues as they are being studied.
