(LAX)/Community Noise Roundtable

Dear Mr. Bronczek:

Los Angeles World Airports (LAWA) hosts a community noise forum called the LAX/Community Noise Roundtable (Roundtable). Its membership consists of local elected officials and staff, representatives of congressional offices, members of recognized community groups, the Federal Aviation Administration (FAA), the airlines, and LAWA management. The purpose of the Roundtable is for the members to collaborate in a non-confrontational manner to identify aircraft noise issues at LAX and to make recommendations to reduce noise affecting the surrounding communities, wherever possible, without shifting noise from one community to another.

One of the current issues that causes noise disturbances to the communities near LAX is aircraft that depart from the south outer runway (25L) instead of the south inner runway (25R). Aircraft departing from Runway 25L will create more noise for residents since it is closer to the neighboring communities. Also, this operation does not comply with the LAX Preferential Runway Use Procedure which requires aircraft to depart on the inner runways and land on the outer runways.

LAWA staff regularly monitor aircraft operations at LAX to determine the compliance rates with this and other noise abatement operating procedures and work closely with the FAA in an effort to improve compliance with these procedures. However, since aircraft operations involve not only the FAA air traffic controllers, but also the pilots-in-command of their respective aircraft, LAWA believes that support from the airlines is crucial in achieving further compliance and bringing meaningful noise relief to the affected communities at LAX.

LAWA and the members of the Roundtable request your assistance in arranging for one of your representatives, preferably the chief pilot who is familiar with LAX operations, to attend upcoming Roundtable meetings. The membership is very interested in working with Fed Ex to find methods to further improve the compliance with the Preferential Runway Use Procedure and in gaining a better understanding from the pilot's perspective of why deviations from this procedure occur.






